Tax reasons

- The lowest tax system in the European Union at 10% on taxable profits
- One of the most favorable Holding company jurisdiction
- Availability of Group losses relief without any time restrictions
- No withholding tax on dividends paid to non-residents shareholders
- Exemption from taxation of capital gains (apart from the sale of immovable property situated in Cyprus)
- Double tax treaties with many countries
- Non resident companies are taxed only on the income derived in Cyprus
- Sales of shares/securities are tax free
- No taxation on dividend income
- VAT registration allows you to reclaim any VAT imposed on local expenses
- Low income tax rates for expatriates
- No inheritance tax

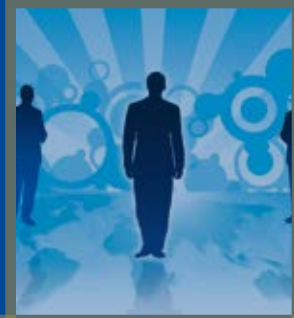

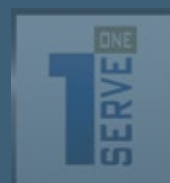
